TRANSITIONAL HOUSING and SUPPORTIVE SERVICES

INTAKE

Our staff processed approximately 1,750 requests for housing assistance and supportive services in 2015.

TRANSITIONAL HOUSING PROGRAM

The Transitional Housing Program* provides safe, temporary housing to families while they are receiving supportive services prior to moving to permanent housing. Virginia Beach Community Development Corporation works in conjunction with local agencies to provide a comprehensive approach to help residents achieve independence and self-sufficiency, maintain employment, increase their skills and income, and obtain permanent housing.

SUPPORTIVE SERVICES FOR VETERAN FAMILIES PROGRAM

The Supportive Services for Veteran Families Program* is designed to promote housing stability among low-income veterans and veteran families who reside in or are transitioning to permanent housing. Eligible veterans may receive rental assistance, security deposits, emergency and general housing assistance, utility assistance, moving costs, transportation, child care, and emergency supplies. This program expanded to include veterans from Newport News and Hampton in 2015, in addition to the original service areas of Virginia Beach, Portsmouth, Norfolk, Chesapeake, Suffolk, Franklin, Isle of Wight and Southampton. The Supportive Services for Veteran Families program played a significant role in exceeding the goals detailed in the 100 Day Challenge initiated by Governor McAuliffe.

NEW SUPPORTIVE SERVICES

Virginia Beach Community Development Corporation launched several new initiatives in 2015 to serve more neighbors in new ways. These additional programs and services are designed to profoundly change the lives of our neighbors.

EMERGENCY SHELTER

Virginia Beach Community Development Corporation expanded its shelter capacity by converting an existing rental unit into a nightly shelter for families with children in need of immediate housing assistance.

The nightly shelter has provided to bed nights to individuals that contacted Virginia Beach Community Development Corporation for assistance in the final quarter of 2015.

ENERGY SHARE PROGRAM

Virginia Beach Community Development Corporation became a service provider for the Energy Share Program through Dominion Virginia Power in October. This program offers bill payment assistance to veteran residents who are facing financial challenges.

Our neighbor advocates helped \bigoplus families complete applications for the Energy Share Program during the final quarter of 2015, resulting in in energy bill assistance.

FOOD PANTRY

Virginia Beach Community Development Corporation became a partner agency of the Foodbank of Southeastern Virginia and the Eastern Shore in November, allowing neighbors in need to receive supplemental nutrition assistance. By implementing a client choice method of distribution, neighbors are able to select foods they need and will be able to use for their families while empowering them as they work toward self-sufficiency.

The food pantry distributed more than 400 pounds of food and provided nutritional assistance to 7 individuals in our community in its first month of operation.



IMPACT STATEMENT

TIARA CLARK

I am truly thankful and grateful for the services I received at Virginia Beach Community Development Corporation. The Intake Coordinator really listened to my story and did all she could to help my family and me after becoming homeless a second time. She was relentless in calling other agencies trying to find possible housing options for my family, and advocated for me to apply for the Transitional Housing Program. We were placed at Virginia Beach Community Development Corporation's shelter while we waited for housing to become available. This shelter provided me with more safety, comfort, stability, and a hope for positive change in my life than in my previous shelter experiences. Virginia Beach Community Development Corporation really impacted my life because it turned me from homelessness to stability.

OWNER OCCUPIED REHABILITATION

The Owner Occupied Rehabilitation Program is funded through a Community Development Block Grant from the U.S. Department of Housing and Urban Development to the City of Virginia Beach. Eligible homeowners could qualify for three types of assistance under this program in 2015: Emergency, Façade, or Home Rehabilitation.

This program helps homeowners in Virginia Beach to make needed repairs to their home in order to correct accessibility barriers, health and safety hazards, and code violations. Assistance is provided through a very low-interest loan, utilizing the neighbor's available equity to finance the rehabilitation.

Virginia Beach Community Development Corporation walks with each neighbor through the entire rehabilitation process from application through project completion. Homeowners receive assistance with financing, inspections and estimates of the work needed, contractor specifications of the project scope, competitive quotes from licensed and ensured contractors, rehabilitation contract oversight, construction management and inspections, and contractor payments once the work is complete.

TALENT

Virginia Beach Community Development Corporation strives to provide a collaborative, creative working environment where each person feels encouraged to contribute to our processes, decisions, planning and culture.

To enhance our goal of collaboration, we have developed three cross-organizational teams including the Leadership Team, Partner Engagement Team, and Wellness Initiative Team. All of the organization's partners are actively involved in one of these teams.

Professional development has been a focus for all partners* throughout 2015.

Plans are underway to earn a Best Place to Work designation. Our success relies on employing the top talent in the field. With the best partners in place, real change will continue to happen for the people we serve.

ENVIRONMENTAL FOOTPRINT

The Virginia Beach Community Development Corporation enhanced its infrastructure to allow partners, contractors, and board members to work and communicate remotely. Virtual collaboration has cut down on transportation to and from meetings—reducing our organizational carbon footprint.

GREEN OFFICE TASK FORCE implemented a recycling program with 100% partner participation and made strides this year by reducing paper utilization by 90%.

VOLUNTEERS




